NCC Dept - Establishment - Appointment of Clerk (Rs. 19000-43000/-) in NCC Department under Compassionate Employment Scheme - Orders issued.

ORDER

1. **Kum. K. Gayathri**, d/o Late P.N Mani, Senior Clerk of 7 (K) Girls Bn NCC, Thrissur who died in harness on 08/11/2012 had applied for employment assistance under the **Compassionate Employment Scheme**. The applicant is aged 24 years and her date of birth is 06.02.1994. The educational qualification of the applicant is Plus Two. As such she is qualified for the post of Clerk.
- 2 In the order read as 2nd paper above Government has accorded sanction for the appointment of Kum. K. Gayathri as Clerk in the existing vacancy of 7 (K) Girls Bn NCC, Thrissur in NCC Department under Compassionate Employment Scheme.
3. In the Circumstances **Kum. K. Gayathri**, R/o Chitranjali, Vijay Nagar, Ayyanthol P.O, Thrissur is temporarily appointed as Clerk on **Rs. 19000-43000/-** under **Compassionate Employment Scheme** and posted to **7 (K) Girls Bn NCC, Thrissur** in the existing vacancy.
4. She is directed to report to **The Officer Commanding, 7 (K) Girls Bn NCC, Thrissur within 15 days** on receipt of this order with necessary documents in original to prove her date of birth, educational qualification and passport size photographs recently taken duly attested by a Gazetted Officer in the Government service. She is also required to produce a medical fitness certificate in original from a Medical Officer not below the rank of an Assistant Surgeon having MBBS degree, failing which she will not be admitted for duty.
5. The appointment of the candidate is temporary under Rule 9 (a) (i) of the General Rules of the Kerala State and Subordinate Service Rules 1958 as provided in the rule 10 (b) of the above rules and also subject to satisfactory report in Police verification later regarding his character and antecedents.
6. The employment assistance ordered under the scheme will be cancelled if and when Government find any suppression or misrepresentation of material facts on the part of the applicant at the time of forwarding application or during the course of enquiry conducted by the District Collector and also if it is proved on examination that the orders were erroneously issued.

7. The details of appointment will be entered in the service book of the deceased employee and the establishment registers of the Department in which the deceased employee last worked and should be attested by the competent authority concerned.
8. She will be on probation in the cadre of Clerk for a period of *two years* on duty within a continuous period of three years from the date of her joining duty during which she has to pass the departmental test of MOP. All relevant conditions laid down in the GO read second paper above also applicable to this appointment.
9. The Head of Office will obtain the endorsed proforma duly filled in by the candidate before he is allowed to join duty for further action. The date of joining duty should be reported promptly. As per Government circular No 20/2003/Fin dated 3rd Feb 2003, the details regarding the quota in which the candidate is appointed should be recorded in her service book.
10. The Head of Office will obtain and submit the application for allotment of **Permanent Retirement Account Number (PRAN)** to concerned Treasury from the individual vide GO (P) No. 49/2013/Fin dated 03.04.2013.
