ORDER

1. **Sri. Balasubramanian.PS**, Selection Grade Typist, while he was working at 24 (K) Bn NCC, Thrissur involved in an 'Abkari Case' and he was arrested and kept under Judicial Custody. Consequently he was suspended from service wef 08/11/2017 vide order cited 1st above.
2. Later the suspension of the above incumbent was revoked vide proceedings cited 2nd above and posted to 21 (K) Bn NCC, Ernakulam. His request submitted for posting to Thrissur District as cited 4th above could not be considered at that stage.
3. In the above situation, Sri. Balasubramanian.PS filed OA as cited 5th above and obtained a judgment with the direction 'to consider his request for transfer and pass appropriate orders as per the provisions of GO' cited 3rd above. But by the time, all the 3 existing vacancies under Thrissur DRB had already been reported to PSC. Since no open vacancy was available, his request for transfer to any NCC Offices in Thrissur couldn't have been considered. Hence a Proceedings issued accordingly as cited 6th above and communicated to Honorable KAT by this Directorate.
4. In view of the above, the incumbent filed another OA as cited 7th above, The Honorable KAT, in its verdict dated 31 Oct 2018 directed that "if vacancies are available, the claim of the applicant who is due to retire on 31.05.2020 would be

considered for a posting till a PSC hand joins duty or till his retirement, whichever is earlier."

5. In the above circumstances and in compliance of the order of Hon'ble KAT, Sri Balasubramanian.PS, Selection Grade Typist of 21 (K) Bn NCC, Ernakulam is here by transferred and posted to 7 (K) Girls Bn NCC, Thrissur. The incumbent is liable to be transferred out of these three posts as and when the candidate to the third vacancy from KPSC reports for joining duty. Therefore he shall be relieved from his duties with immediate effect.

6. In this regard, the Head Office is requested to download this transfer order from website and handover one copy to the above transferee. The actual date of joining/relieving duty should be reported immediately to this Directorate.
