ORDER

Government, as per order read as 1st paper above has issued orders to create 327 supernumerary posts in Government departments including NCC Department for the candidates awaiting appointment under CES. Thereafter Government, as per order read as 2nd paper above has issued orders to appoint 07 candidates on supernumerary post in this Department. Further, Government, as per letter cited as 3rd paper above has forwarded a court direction dated 25.02.2016 in WP (C) No 33621/2015 & 5960/2016 directing not to create any supernumerary post for making any appointment or regularisation of compassionate appointees. Thereafter, Government, as per letter read as 4th paper above has directed to issue orders for appointing 07 candidates in supernumerary list as per Government, order read as 2nd paper in this Department, under Compassionate Employment Scheme and this Directorate, as per Proceedings read as 5th paper above had issued orders to appoint them in this Department, with immediate effect and subsequently they have joined duty in this Department.

2. Government accorded sanction for appoint them in the supernumerary post, where as this Directorate erroneously issued orders to appoint them in the regular vacancies. As such, it has been decided that the CES appointment ordered as per proceedings read as 6th paper will be in the supernumerary posts and to seek clarification from Government regarding their regularisation.

3. In view of the above, it is ordered that the Compassionate Employment Scheme appointment order as per proceedings read as 5th paper above will be on supernumerary posts with effect from their date of joining duty in this department.

4. As such, this Directorate proceedings read as 5th paper above stands modified to that effect.


