ORDER

1. Consequent on retirement of Sri Mohanan TK, SMM, 9 (K) Naval Unit NCC, Kozhikode and Sri. Chidambaram CP, SMM, 7(K) Naval Unit NCC, Ernakulam, two vacancies of SMM arose, in 9 (K) NU NCC and in 7(K) NU NCC respectively. At the same time Sri. Nandakumar K, SMM of 1 (K) Naval Unit NCC, Thiruvananthapuram was transferred to 9 (K) Naval Unit NCC, Kozhikode. Hence the vacancy arose in 1(K) Naval Unit NCC, Thiruvananthapuram instead of 9 (K) Naval Unit NCC, Kozhikode. In order to fill up vacancies, applications were invited from eligible candidates having requisites qualifications as per this Directorate letter read as 1st paper above and three applications were received in this Directorate for consideration.
