

**MINUTES OF THE MEETINGS OF GREVENCES REDDRESSAL FORUM HELD ON 10 NOV 2017 AT THE
CHAMBER OF DIRECTOR, NCC DIRECTORATE (K&L), THIRUVANANTHAPURAM**

The meeting started at 1130 hrs and following officials participated in the meeting.

At the outset the actions taken on the basis of decision of the last meeting have been discussed in detail. The representatives belonging to various service organizations have put forward their suggestions. Points discussed in detail and following decisions taken :-

1. KNCC CSA representatives brought to notice of the forum that non – implementation of decision taken in the meeting held at 07 & 08 May 2013 respectively in Dte and Secretariate (H.Edn Dept). Withdrawal of case filed by Gp Cdr, Kollam against members of KNCC CSA.

During last redressal meeting the same point was reported and the Director has reported that the matter cannot be considered now as the same is subjudice.

2. KNCC CSA brought to notice that violation of Govt Orders while issuing Inter District Transfers and DRB Rules. Copy/copies of Govt Orders as mentioned at Para 1 (d) of NCC Dte (K&L) letter No 8941/A1-Est/2017/NCC dated 30.10.2017 may please be provided to us to clarify and inform all concerned that transfers are in accordance with the prevailing rules.

Copies of relevant orders of Govt were given to representatives of the KNCC CSA who attended the meeting and it was clarified to them that no Govt orders have been violated.

3. The KNCC CSA has brought that delay in framing of Special Rules.

The Draft Special Rules prepared for this Dept has been forwarded to Govt and awaiting further communication from Govt.

4. The KNCC CSA also asked the progress / action taken on confirmation of employees appointed after 2007.

Necessary orders will be issued on obtaining clarification from Govt.

5. KNCC CSA asked about the finalization of enquiry report on missing service books and action taken for publication of Govt Order for making new service books.

Director informed them that no such missing of service books has been reported in this dte. The Director has also requested to specify the name of employee who's service book has missed.

6. KNCC CSA brought to the notice of the forum that the issue of detailed instructions by NCC Dte specifying Controlling Officer, Sub-controlling Officer and DDO.

Director informed that action on issue of detailed instructions regarding Controlling Officer, Sub-Controlling Officer and DDO in the NCC Dte will be taken only after the receipt of clarification from Govt.

7. KNCC CSA representatives asked to know the progress / action taken for appointing Record Keeper at NCC Dte as per MOP.

Director informed that no such post of Record Keeper is authorised in this Directorate.

8. KNCC CSA asked forum to know action on pending applications for request transfer.

Director informed them that all pending applications for transfer will be considered soon.

9. KNCC CSA also asked clarification regarding appointment of new Chowkidars in 27 (K) Bn NCC, 29 (K) Bn NCC, 31 (K) Bn NCC on provisional basis vide NCC Dte proceedings No 6375/A6-Est/2017/NCC dated 13 Jul 2017.

Director informed that units are already permitted to appoint Chowkidars on provisional basis.

10. KNCC CSA representatives asked action taken against Sri. Pradeep S, Senior Clerk after getting his advice cancellation information from KPSC, Thiruvananthapuram.

The case was pending at Hon'ble KAT and the individual has obtained stay. Action will be taken as per the final verdict of the court.

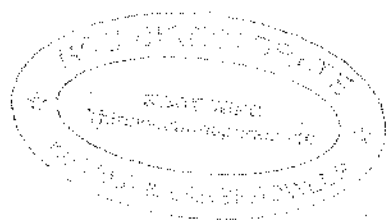
11. NGO Union asked to adopt introduction of noting system as per MOP in NCC Group Headquarters and Units.
