**ORDER**

2. Sri.Chandrabhanu PM, Senior Clerk, 31 (K) BN NCC who relinquished his promotion to the Cadre of HC/JS on September 2017 and continued as Senior Clerk at 31 (K) Bn NCC has requested to withdraw his relinquishment with immediate effect vide letter cited 4<sup>th</sup> above.
