NCC Dept- Est – Appointment Sri. Hari PT, LD Typist, GP HQ, Kollam – Removing from service from the duties of LDT since cancellation of PSC Advise – Orders issued.

ORDER

Sri Hari PT was advised for appointment as LD Typist in this department as per KPSC advice letter read as 1st paper above. Therefore, he has been appointed as LD Typist and posted at NCC GP Hqs Kollam as per this Directorate proceedings read as 2nd paper above and joined duty as LD Typist wef 12/4/2017.

Now, KPSC District Officer, Kollam as per letter read as 3rd above has informed that, the Rank list published for the post of LD Typist (EX Serviceman only) in Kollam district has been revised by adding weightage marks to the Ex Servicemen candidates who served in the Clerical cadre Class I category in the military. As such, the Rank list published has been re-arranged and candidate who scored marks more than Sri Hari PT has been placed above him as Rank 1A in the Rank List. Therefore as per Rule3(c) of the KS&SR 1958, the KPSC has tentatively decided to cancel the advice issued as per letter read as 1st paper above.

In view of the above, KPSC has directed this department to remove Sri Hari PT from the Govt. Service with immediate effect in order to enable them to advise another suitable candidate for appointment in this department as LD Typist at the earliest.

In the above circumstances, it is to inform that Sri Hari PT, LD Typist NCC GP HQ, Kollam is removed from the Kerala State Govt Service for want of vacancy with immediate effect.

The Group Commander, NCC GP HQ, Kollam is requested to relieve him from the duties of LD Typist with immediate effect in compliance with KPSC directions as letter read as 3rd above.

Necessary entries should be made in the service book of the incumbent under proper attestation.
