NCC Establishment – By transfer promotion-Appointment of Ship Modelling Store Keeper Grade II on scale of pay Rs 18000-41500/- in Kollam, Kottayam, Ernakulam and Kozhikode Districts - orders issued.

ORDER

Consequent to retirement/promotion, four vacancies, of Ship Modelling Store Keeper have arisen one each in 3(K) Naval Unit NCC, Kollam, 5 (K) Naval Unit NCC, Changanacherry, 7(K) Naval Unit NCC, Ernakulam and 9(K) Naval unit NCC, Kozhikode. In order to fill up the vacancies by promotion from lower categories, this directorate as per letter read as 1<sup>st</sup> paper above had invited applications from all eligible candidates of this department for promotion to the post of SMSK and ten applications were received. Thereafter a Board of Officers was detailed to select suitable candidates as per this Directorate letter read as 2<sup>nd</sup> paper above. As per suitability list submitted by the Board of Officers this Directorate issued Appointment Order as per letter read as 3<sup>rd</sup> paper above and filled up the existing vacancies.

2. After the completion of selection and appointment process cited above, a submission received from Sri. Shaji DS, Lascar Gr-II and Sri Mohanan Pillai R Lascar Gr II of 3 (K) Naval Unit NCC stating that they are not aware of date of interview by the Board of Officers. After scrutinizing the above circumstances this directorate cancelled the proceedings of appointment read at 3<sup>rd</sup> and a fresh Board of officers was detailed for a fresh selection process as per letter read as 4<sup>th</sup> paper above.

3. As such the new Board of Officers have submitted the suitability report for filling the existing vacancies. Five candidates have been found suitable for SMSK post as against four vacancies existing in this department. Out of the selected candidates, Sri. Sunil Kumar PT, OA Gr-I of 9(K) Naval Unit NCC have also been selected for the post of Clerk by transfer promotion and he has opted for the post of Clerk discarding by transfer promotion to the post of SMSK. Hence, the following four candidates are recommended for appointment as SMSK in this Department in the existing vacancies.

4. In view of the above, the undersigned is pleased to promote the above candidates for appointment as Ship Modelling Store Keeper in the scale of pay Rs 18000-41500/- and they are posted in the following offices as given below:-

(a) Sri. Mohanan P, OA Gr-II, 30 (K) BN NCC, Kozhikode is promoted as Ship Modelling Store Keeper Grade II and posted to 9 (K) NU NCC, Kozhikode in the existing vacancy.

(b) Sri Muraleedharan P Lascar Gr – II, 9 (K) Naval Unit, Kozhikode is promoted as Ship Modelling Store Keeper Grade II and posted to 7(K) Naval Unit NCC, Ernakulam in the existing vacancy.

(c) Sri. Saseendran VK, Lascar Gr-II, 1(K) NU NCC Thiruvananthapuram is promoted as Ship Modelling Store Keeper Grade II. and posted to 3 (K) Naval Unit NCC, Kollam in the existing vacancy.

(d) Sri. Shaji T, Chowkidar Gr-II, 5(K) NU NCC, Changanasserry is promoted as Ship Modelling Store Keeper Grade II and posted to 5(K) NU NCC, Changanasserry in the existing vacancy.

5. The promoted incumbents will be on probation in the cadre of Ship Modelling Store Keeper for a period of two years on duty within a continuous period of three years from the date of assuming duty as SMSK. They are also required to exercise option under para 40 of GO (P) No. 07/2016/Fin dated 20.01.2016, within one month from the date of promotion.

6. Necessary entries will be made in the service book of the incumbents regarding change of category under proper attestation.

7. The date of joining duty as SMSK should be reported to this Directorate by the units concerned promptly.
