Since KFC Vol-I & II are silent on detailment of Board of Officers and HOD of the NCC Department, other Commanding Officers re not State Government officers, status quo for detailment of board of officers may be maintained. However, form IAFD-931 is not to be used for state stores as the same is used for Indian Armed Forces.
