**ORDER**

1. Government as per Order read as 1<sup>st</sup> paper above has revised the financial powers delegated to the Heads of Departments in the State and issued directions that, **"the HOD of the Department may without the concurrence of the Government, sanction Permanent Advance limited to a maximum of Rs, 20,000/-. The Orders will be issued on the recommendation of Accountant General in conformity with Article 95 of the KFC Vol-I"**.
2. In the above circumstances, this Directorate as per letter No. read as 2<sup>nd</sup> paper above had taken up a case with the Accountant General, Thiruvananthapuram to consider enhancing the ceiling of Permanent Advance.
3. Now, the Accountant General, Thiruvananthapuram as per letter read as 3<sup>rd</sup> paper above has informed that, they have no objection in sanctioning/enhancing a Permanent Advance in the following rates to each office as given below :-

S.No.	Category of Offices	Total Amount in Rupees
(a)	NCC Directorate	20000
(b)	NCC Group Headquarters	15000
(c)	NCC Units	5000

4. In view of the above, the undersigned is pleased to accord sanction to the **Drawing and Disbursing Officer** of NCC Directorate, Group Headquarters and NCC units as shown above and adhering with following directions :-

- (a) The amount sanctioned is subject to review and re-fixation after a period of one year
- (b) The officers responsible for the safe custody of the money will forward an acknowledgement to the Accountant General for the amount of the Permanent Advance on the 15<sup>th</sup> April of every year and whenever there is change of the incumbent as

contemplated in Article 96 of Kerala Financial Code Vol-I with designation of the DDO. (The acknowledgement should be in Form No.8 when there is a change of incumbent and in Form No. 8A in other cases).

- (c) DDO concerned will maintain a register in form T.R.96 and adhere to the rules relating to Permanent Advance as laid down in Article 96 to 98 of KFC Vol-I.

5. The amount may be drawn by debit to the Head of Account "**L. suspense and Miscellaneous (C Other accounts 8672 Permanent Cash Imprest (101) Civil (State/Central)**"
