ORDER

As per the Government order read 1st paper above, Administrative Sanction was accorded for 3.00 crore for the construction of permanent camp site with plinth area of 1980 m² at Akkulam, Thiruvananthapuram. As per the Government order read 2nd paper above, revised Administrative Sanction for an amount of 13,21,00,000/- (Rupees Thirteen Crore Twenty One Lakh only) from the Head of Account 4202-03-800-91 was accorded during the financial year 2014-15, for construction of block for Boys and Girls, Administrative block and NCC Camp site, at Akkulam, Thiruvananthapuram with detailed plinth areas of 5095 m² (G+3 floor building). This project was delayed for want of CRZ clearance from Kerala Coastal Zone Management Authority. The Additional Director General, NCC, as per the letter read 3rd paper above has informed that CRZ clearance has been obtained, by limiting the height of the building to 9 m. Accordingly, the Additional Director of General, NCC as per the letter read 5th paper above has submitted a revised estimate for two floor building (G+1) with a detailed plinth area of 3137m² amounting to 10 Crore, for according revised Administrative Sanction for 10,00,00,000/- (Rupees ten crores only), for construction of Naval Training Centre and Cadets Accommodation block for Ladies & Boys at 1 Kerala Naval NCC at Akkulam, Thiruvananthapuram.

2. Government have examined the matter in detail, and are pleased to accord revised administrative sanction for an amount of Rs.10,00,00,000/- (Rupees ten cores only) for the construction of of Naval Training Centre and Cadets Accommodation block for Ladies & Boys at 1 Kerala Naval NCC at Akkulam, Thiruvananthapuram (two storied building), subject to the condition that the work shall be done utilizing the amount already deposited with PWD in 2014 and subject to the compliance of following observations in the technical sanction:-


- 1) The foundation shall be redesigned for G+1 structure.
- 2) The provision for extra cement for design mix is not necessary as the work is tendered on item rate and the excess cement provision shall be deleted.
- 3) The quantity of steel reinforcement is taken as per thumb rules. This quantity has to be calculated as per structural designs.
- 4) Provision for utilizing the departmental earth obtained from earthwork excavation needs to be included.
